This STALLION BREEDING CONTRACT for the breeding season of 20 \_\_\_\_, is made and entered into on this \_\_\_\_ day, of \_\_\_\_, 20 \_\_\_\_ is by and between High Plains Genetics, LLC, hereinafter designated Breeder, and \_\_\_\_, hereinafter Mare Owner. Mare Owner agrees to breed the mare Reg. No. \_\_\_\_, to stallion - Coronas Dun Playin \_\_\_\_, Reg. No. 5473933, owned by Jeff & Michelle Fields for the fee of \$ 1,200.00, for a live foal, subject to the following conditions.

- 1. The stallion fee includes a nonrefundable booking fee of \$ \_\_\_\_, payable with this contract, the balance of which must be paid with all other expenses when mare is picked up. Mare Owner may not remove mare from Breeder's possession until all expenses are paid in full.
2. Breeder agrees to provide suitable facilities for the care and feed of the mare and/or foal while in its custody. Mare Owner agrees to pay for care and feed at the rate of \$ \_\_\_\_ per day for wet mares; \$ \_\_\_\_ per day for dry mares.
3. Breeder will exercise judgement consistent with recognized standards in care and supervision of mare and/or foal. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary. Breeder's veterinarian will examine mare for normal breeding conditions and administer medical care as deemed necessary for the health and safety of the mare and/or foal. All veterinarian and farrier expenses will be paid by Mare Owner.
4. The mare shall be in a healthy and sound breeding condition, free from infection, contagious or transmissible diseases. Mare must have a current negative Coggins Test, a current health certificate issued by a licensed veterinarian and a photocopy of registration papers upon arrival. Mares not halter broke will not be accepted. If a mare is refused, the booking fee shall constitute liquidated damages.
5. Breeder agrees to diligently try to settle mare; however, if mare fails to settle, for any reason, Mare Owner will hold Breeder blameless. Mare Owner must leave mare with Breeder until Breeder's veterinarian pronounces mare safe in foal, to insure "Live Foal Guarantee". If Mare Owner chooses not to leave mare with the Breeder after the mare has been bred then it will be up to the Mare Owner to have the mare ultra-sounded by a licensed veterinarian 14-16 days after being bred. The results need to be sent to the Breeder. Any mare not ultra-sounded 14-16 days after being bred will make the "Live Foal Guarantee" null and void.
6. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, there are return privileges for the 20\_\_ season only if Breeder is notified within \_\_\_\_ days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal", the mare should miscarry, abort or prove barren after leaving the Breeder's premises. Mare Owner has the privilege to return her for breeding during the current breeding season \_\_\_\_ through \_\_\_\_, or the following year, 20\_\_\_.
7. A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when stallion fee and all other expenses have been paid in full; and, when mare has produced a live foal by this mating.
8. Both parties agree that High Plains Genetics, LLC, the Breeder, their agents or employees are not liable for death, sickness and/or accidents including consequential damages caused to the mare and/or foal; and, the Mare Owner is not liable for death, sickness and/or accidents including consequential damages caused to the stallion.
9. It is further agreed that should the stallion die, be sold by the owner, or become unfit for services prior to settling the mare, that the breeding fee will be refunded, if it has been paid in full. If the mare dies or becomes unfit to breed before pronounced safe in foal, the Breeder will accept another mare upon approval.
10. This Contract is nonassignable and nontransferable. Breeder strongly recommends Mare Owner carry full insurance on mare and/or foal. Company \_\_\_\_ Policy Number \_\_\_\_\_. This contract is entered into in the State of South Dakota and will be interpreted and enforced under the laws of that state.
11. This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.
